AMIGO ROAD PROPERTY OWNERS ROAD MAINTENANCE AGREEMENT

THIS AGREEMENT is made on the dates set forth below in the County of Santa Cruz, State of California, by the parties described below for the purpose of establishing mutual rights and obligations with respect to the maintenance of a common road, and the parties therefore agree as follows:

1. **PARTIES.** The addresses of the parties and the parcels of property of present and subsequent owners to which all rights and obligations set forth herein attach are: (Refer to Appendix A for the names of the owners of the parcels of property on the date of recording of this document).

- 2. **ROAD DESCRIPTION.** This agreement shall apply to the private road known as Amigo Road, extending from Rodeo Gulch to Outlook Ridge Road.
- 3. MAINTENANCE OBLIGATIONS. Each party to this agreement, including each subsequent owner of any parcel (as described in Section 1) by acceptance of a deed, hereby covenants to pay assessments for maintenance of the road as provided hereinafter. Assessments shall be determined by majority vote of a quorum of attendees at owners' meetings, as defined in "VOTING RIGHTS", or by majority proxy vote of all owners conducted by the Executive Secretary. The assessments shall be a continuing lien upon the parcel of property against which each assessment is made. Each such assessment, together with interest, costs, and reasonable attorney's fees, shall also be the personal obligation of the owners of such property at the time when the assessment fell due.
- 4. **PURPOSE OF ASSESSMENTS.** All assessments shall be used exclusively for the maintenance and repair of the road described in Paragraph 2. Such maintenance and repair shall include resurfacing and repair and replacement of drainage systems as may be reasonably required to maintain the road in a condition suitable for normal pedestrian and noncommercial vehicular use.
- 5. RATE OF ASSESSMENTS. All assessments shall be charged to and divided among the parties based on division of the road system into four zones: (1) Rodeo Gulch to Bronco Road (Zone 1); (2) Bronco Road to Mt. Messiah Grade (Zone 2); (3) Mt. Messiah grade to Felicidad (Zone 3); and (4) Felicidad to Outlook Ridge Road (Zone 4). The owner(s) of each property accessing the road from Rodeo Gulch to Bronco Road (Zone 1) shall be responsible for one share of all costs and expenses incurred to maintain and repair the road situated in Zone 1; The owner(s) of each property accessing the road from Bronco Road to Mt. Messiah Grade (Zone 2) shall be responsible for one share of all costs and expenses incurred to maintain and repair the road situated in Zone 1 and Zone 2; The owner(s) of each property accessing the road from Mt. Messiah grade to Felicidad (Zone 3) shall be responsible for one share of all costs and expenses incurred to maintain and repair the road situated in Zone 1, Zone 2, and Zone 3; The owner(s) of each property accessing the road from Felicidad to Outlook Ridge Road (Zone 4) shall be responsible for one share of all costs and expenses incurred to maintain and repair the road situated in Zone 1, Zone 2, Zone 3, and Zone 4.

- 6. **ANNUAL MEETING.** An annual meeting of the owners shall be held each June at a date, time, and location to be determined by the Executive Secretary. Additional meetings may be scheduled throughout the year to conduct business as required to maintain Amigo Road. All meetings shall be conducted in conformance with "Robert's Rules of Order".
- 7. **VOTING RIGHTS.** Each owner(s) shall have a number of votes equal to the number of individual parcels owned by such owner and served by the road. All votes for each parcel shall, if at all, be cast as a unit. In the event that joint owners are unable to agree among themselves as to how their vote or votes shall be cast, they shall lose their right to vote on the matter in question. If any owner casts a vote or votes representing a certain parcel, it will thereafter be conclusively presumed for all purposes that said owner was acting with the authority and consent of all the owners of the lot. A quorum is defined here as the presence of at least 60% of the owners (including proxies) at a meeting, excluding those owners not a party to this agreement. If a quorum is present at a meeting, a majority of votes at a meeting shall be considered a majority vote for the owners. Any owners not choosing to be a party to this agreement lose their vote, but are still legally responsible for, and will be held accountable for, their fair share of the road maintenance costs.
- 8. **NOTICE OF MEETINGS.** Any action authorized under this agreement shall be taken at an annual meeting as provided herein, or at a special meeting called by the Executive Secretary. Written notice of all such meetings shall be sent to all owners not less than ten (10) days nor more than ninety (90) days in advance of the meeting specifying the place, day and hour of the meeting and in the case of a special meeting, the nature of the business to be undertaken. Members who are unable to attend any such meeting in person, may vote by written proxy, or may give their assent in writing to any action taken not later than thirty (30)days from the date of such meeting.
- 9. REMEDIES FOR NON-PAYMENT OF ASSESSMENTS. Any assessment not paid within thirty (30) days after the due date shall bear interest at the rate of ten percent (10%) per annum from the date due until paid. When a notice of assessment has been recorded, such assessment shall constitute a lien on each respective parcel prior and superior to all other liens except (1) all taxes, bonds, assessments and other levies which by law would be superior thereto, and (2) the lien or charge of any first mortgage of record made in good faith and for value. Such lien, when delinquent, may also be enforced by a voluntary sale lien on the property or by civil action in small claims court or higher courts, as applicable, or in any other manner permitted by law.

- 10. MANAGEMENT. At each annual meeting the owners shall appoint by majority vote of a quorum an Executive Secretary, a Treasurer, a Road Committee, and such other officers as the owners deem necessary or convenient to perform the duties and responsibilities required under the terms of this agreement. The Executive Secretary, a Treasurer, a Road Committee, and other officers shall continue in such positions until the end of their term, or until terminated by resignation or by vote (or written consent) of the owners of a majority of the parcels. Their duties shall include, but not be limited to, collecting and managing the road maintenance funds as set forth in this agreement, employing contractors or employees to perform the maintenance work as set forth in this agreement, providing notice and presiding at meetings of the owners, obtaining necessary insurance, and employing attorneys, accountants or such other individuals or firms as are reasonably required to carry out the purposes of this agreement. All expenditures require prior approval by quorum majority vote of the owners with the following single exception: the Road Committee may expend up to \$1000 at their discretion for road maintenance and repairs without prior approval. However, any such expenditure must be approved by a quorum of the owners before subsequent discretionary expenditure of up to the \$1000 limit can occur. Expenditures from \$1000 to \$5000 require signature of the Treasurer. Expenditures over \$5000 require approval of the Treasurer and one other officer, such as the Executive Secretary or a member of the Road Committee. Signature approval documents shall be maintained at the applicable banking facility.
- 11. **DAMAGES TO ROAD.** In the event that any party to this agreement shall cause, by any act or omission, damage to the road, said party shall be solely responsible for all costs and expenses incurred in repairing such damage.
- 12. **ROAD MAINTENANCE FUND MINIMUM BALANCE.** The owners shall maintain at least Five Thousand Dollars (\$5,000) minimum balance in the road maintenance fund. Each parcel shall contribute equally to the minimum balance. The minimum balance shall be used solely to fund repairs to Amigo Road which are necessary to restore or preserve access to individual home sites and which cannot reasonably be deferred and undertaken as part of normal road maintenance.
- 13. **REPLENISHMENT OF FUND.** Immediately following any use of the funds which depletes the balance below the minimum, the amount required to replenish the fund shall be repaid to the fund by the owners of the parcels in the zone or zones affected by the repair.
- 14. **EARNINGS.** Interest earnings of the road maintenance fund shall be added to the fund account balance.
- 15. **RECORDING.** The parties intend that this instrument shall be recorded in the Official Records of the Santa Cruz County Recorder.

- 16. SUCCESSORS. The rights and obligations created by this instrument shall be appurtenant to the parcels of land described herein, and shall be binding upon and inure to the benefit of the parties, their heirs, successors and assigns with respect to said parcels.
- 17. **ARBITRATION.** Any controversy or claim arising out of or relating to this agreement, or the making, performance or interpretation thereof, shall be settled by arbitration in the County of Santa Cruz and judgment on the arbitration award may be entered in any court having jurisdiction over the subject matter of the controversy or claim. The arbitration shall comply with and be governed by the provisions of the California Arbitration Act, Sections 1280 through 1294.2 of the California Code of Civil Procedure.
- 18. **ATTORNEY'S FEES.** If any legal action, arbitration or other proceeding is brought arising out of this agreement, the successful or prevailing party shall be entitled to recover reasonable costs and attorneys' fees incurred in that action or proceeding, in addition to any other relief to which the party may be entitled.
- 19. **COUNTERPARTS.** This agreement may be executed in counterparts, each of which shall be deemed an original, but all of which, together, shall constitute one and the same agreement.
- 20. **NOTICES.** Any notice, demand, request or other document or instrument which may be or is required to be given under this Agreement shall be given only in writing and shall be deemed delivered if sent by the United States Mail, postage prepaid, certified, return receipt requested, or by a national overnight delivery service, and shall be addressed to the last known address of the party to whom such notice is to be given. Notices shall be effective upon deposit with a reputable overnight delivery service or in the United States mails in accordance with the above provisions. Each party may designate such other address as shall also be given such written notice. Other modes of delivery may also be utilized, provided such other delivery service can provide a proof of delivery.
- 21. **NECESSARY ACTS.** All parties to this agreement agree to execute, acknowledge and deliver all instruments and perform all acts reasonably required to carry out the intent of this agreement..
- 22. **AMENDMENT.** This agreement may only be amended by a writing signed by the owners of not less than 75% of the parcels affected.
- 23. **ENTIRE AGREEMENT.** This agreement constitutes the entire agreement between the parties and no representations, warranties, conditions, understandings, or agreements of any kind shall be binding on any party unless incorporated herein. This agreement shall not be modified or altered except by written agreement signed by the parties.
